I want to draw your attention to the serious social problem and a great and obvious flaw in the Law. There are hundreds of women, juveniles (girls and boys), and old men detained in the jails under sections of **ABETMENT** who are not accused in reality and are blamed by the complainants. In fact it is a common practice that when someone commits a crime, the Complainants always name whole family including women, young girls, children and parents of the accused in the FIR inspite of them being innocent. It has been pointed out by many prisoners in the jails that the police officers themselves guide the complainant to name whole family as abettors so that they may take heavy bribe by excluding the names of the innocent members of the family later in the investigations. Due to poverty such people who are unable to offer heavy bribes remain in the jails for years which result injustice, great burden on the state and also create retaliation against the government and police resulting creation of new criminals in society and big enmities.

Existing law was made in the pre independence regime. Some sections of law were framed by the British dictators in such a way that public could be crushed and those provisions in Law helped the administration to involve many innocent persons in the crime committed by one person to terrorise and pressurise the public and freedom fighters of the time. Currently those are often used for the political victimisation and enmities. All such provisions and sections of law are inhuman, cruel and against the fundamental rights provided by the constitution of Pakistan. Those laws have not been amended or removed by the law- makers of Pakistan even yet after fifty-two years of independence. These need to be amended immediately to provide basic fundamental rights and end of injustice amending such aristocratic laws to restore democracy in the country. I have been making efforts for the last four years to get remove them from the statute book of Pakistan.

After a survey of the jails during years and the data and information collected, I have come to the conclusion that all the cases of **ABETMENT** are based on an evidence of a third person arranged by the complaint telling the so called story of being the witness of the conspiracy planned by such persons including the accused which was heard by him

It is obviously foolish and tricky way of proving such crime or conspiracy and to involve innocents in the crime. How did the witness come to know about the conspiracy unless he was also a part of this crime or conspiracy. It is common practice that all such allegations are bogus and self produced by the complainants to prove the innocent persons guilty.

During the survey of different jails a conclusion is made that 50% prisoners detained under miscellaneous crimes with abutment are innocent and are being involved in abutment due to political rivalries and old enmities. Many innocent girls and old parents are also detained in the jails under sections 108 or 109 PPC in the false kidnapping cases where the boy has taken the girl to get marry away from her home without the consent of her parents. In such cases most of the people are unaware of their fundamental rights and law of their rights of conjugal affairs.

Sections 107, 108 and 109 of PPC (ABETMENT) should be amended to provide fair justice. This will decrease the burden on state, minimise corruption in the police department and will end the misuse of said sections of law and increasing enmities due to the said cause.

**SECTION 107 of PPC "Abetment of a thing: A person abets the doing of a thing**  
Who—

First: Instigates any person to do that thing; or  
Secondly: Engages with one or more other person or persons in any  
Conspiracy for the doing of that thing, if an act or illegal omission  
takes place in pursuance of that conspiracy, and in other to the doing  
of that thing; or

Thirdly : Intentionally aids, by any act or illegal omission, the doing  
of that thing.

**PROPOSED AMENDMENT:** The Sections 107, 108, 109 of PPC should be subject to confession of or statement of the accused for the involvement of such person or persons in "Instigation, engagement, in conspiracy or Intention of aids" before the Police.

**EXPLANATION:** After the verification and confession of such person or persons involved in Instigation or Engagement or conspiracy or Intention of aids by the accused, the police may add the name or names of the abettors in the ZIMNI and not in the FIR at the time of registration of the case.
