SUBJECT: Timeline of Shumaila Malik Dissolution of Marriage case:

With reference to my previous letter dated 16th January 2014 this is the continuation of the letter, with respect to the above mentioned case; please be advised that the behavior and dealing of Secretary 1, Mr. Shiraz Sindhu is very humiliating and Harassing. That I have experienced from my visits at 99-union council office Gulberg 3-lahore in past. therefore,

1. I visited 99-union council office on Tuesday 3rd December 2013 with Mr. Mansoor (Chairman Insaf society international) in order to prevent from Mr. Sindhu's Harassment but he was not present in the office.
2. I visited the Union council 99 office twice after december 3rd 2013 but again he was not available in Union council 99 office.
3. Therefore, I sent him my documents of Court Decision of Dissolution of Marriage on December 9th 2013 by registered letter.
4. Thereafter, I called Mr. Sindhu from 0302-5150792 on his number 0321-4993609 and he again started humiliating me for calling him on this number instead of calling him on 0301-4243599. I explained him my case and tried to confirm from whether he has received my documents or not but he refused of receiving any documents. Further he misbehaved with me and ordered me to come in person and pay him some money for notices and miscellaneous expenses.
5. Chairman Insaf Society International Called Mr. Sindhu to check the status of the case and he was told by Mr. Sindhu that will issue the notices and put the case as pending until Ms. Shumaila Malik will appear before me in my office. Further He advised that he does not accept the Court Orders because that is only for "GETTING RIGHT OF KHULAH" and is not order for the dissolution of marriage. The case will only be when Mr. Sindhu will his procedure of sending notices; and advertising in the newspapers that will take a period of 90 days after he will register the case in the Union Council register.
6. I again sent Mr. Sindhu a reminder of my case by a registered letter on 13th of January 2014 and visited TMA office to file a complaint against him.
7. I met Mr. Saqlain Mehmood Rana whom promised me to review my case and asked me to see him on 15th January 2014. I also requested him to give me a copy of the UNION COUNCIL ACT which he never provided me to date.
8. Chairman Insaf Society International called Mr. Saqlain on 15th January 2014 at 11:00 a.m but he showed his inability to talk for certain reasons. Thereafter, I personally went to Mr. Saqlain's Office but he was unavailable and his staff sent me to another Union Council office situated near Barkat Market, Garden Town Lahore, where I was asked to Re Submit my Documents where I had to deal with 6-7 strange Men.
9. On 16th January 2014 I went to Mr. Saqlain's office again and he was not available there.
10. Mr. Syed Imran PA to Mr. Saqlain told me that Mr. Sindhu has registered my case on January 6th 2014. and advised me to file a complaint against him but he refused to give me the receipt of my complaint which I had to send by registered letter on 16th January 2014.
11. I also sent SMS msgs to Mr. Sindhu As well as Mr. Saqlain reminding them for my case but there is no response from both of them.

I hope that you will understand the problem and I request you to review my case that I understand is not dealt with properly and looks like a procedure that has been finalized by the Court
