Resultantly, I may be considered as treated in a similar way of man dominating society so that I may not be able to advocate all poor women of Pakistan whom were being victimized in past and will be victimized in future by union councils employees as I went through the situation because I believe advising one secretary not to do such practices is not the remedy of changing system of illegal and unlawful practice by hundreds of union councils offices in Pakistan where divorced women have been and will be possibly intimidated for sexual favors and or for sexual assault committed by certain union councils officials for handing over the divorcee registration certificate.

That I humbly request the honorable court to release written judgment of my petition # WP-3967 as this will be for the protection of all Pakistani women as by default relief and they will be prevented from sexual assault, intimidation for sex favors, bribery, injustice and corruption by such corrupt Union Councils Employees. As it has been observed in my case that those employees of union council # 99 along with TMA Gulberg, administrator Mr. Rana Saqlain Mehmood are so strong and influential whom did not bother to appear before the honorable court in time despite of warrants sent to them by the court of justice.

That it is easily determinable that how can a common woman dare to resist or raise her voice against those influential and strong government employees.

That I spent a lot of time, energy and money to file this writ petition to get justice for all women living in Pakistan whom do not have resources, awareness, knowledge and sufficient funds or to reach the Higher courts and know their rights to get the justice according to teachings of Islam and Sunnah of Prophet Mohammad (peace be upon him).
